**Tax Issues**

**Proposition I and II were passed in the April 8, 2008 elections.**

Kurt Shryack motioned that the Town Council adopt the below named Ordinances that were passed in the April 8, 2008 Special Election. Dallas Lancaster 2<sup>nd</sup> the motion.

**Ordinance No.02-1 of Huntsdale, Missouri, passed March 20, 2007, proposing a Village sales Tax at the rate of one-half of one percent (.05%) on the receipts from the sale at retail of all tangible personal property or taxable services at retail, subject to the sales tax imposed by the State of Missouri (and on residential utility service).**

**Ordinance No.02-2 of Huntsdale, Missouri, passed March 20, 2007, proposing a Village property tax of fifty cents per one hundred dollars assessed value.**

**Building Code Committee**

Discussion on purchasing of electronic version of the 2006 International Building Codes. Dorthy Eberhart motioned that the town purchase the \$65 PDF version of the 2006 International Residential Building Codes. Kurt Shryack 2<sup>nd</sup> the motion.
